**Response to Positive Offender Behavior Guidelines**

<p><b>Level I (larger positive behaviors):</b></p> <ul style="list-style-type: none"><li>• Obtaining employment.</li><li>• Completion of work experience/community service.</li><li>• Excellence demonstrated in structured job search.</li><li>• Exceeding program requirements.</li><li>• Maintaining employment for &gt; 1month.</li></ul>	<p><b>Incentive/Reward Options:</b></p> <ul style="list-style-type: none"><li>• Graduation.</li><li>• Decrease reporting.</li><li>• Progression/move in RTW tiers.</li><li>• Offer mentorship opportunities.</li><li>• Bus passes.</li><li>• Gift certificates (\$10/30 days of work)</li><li>• Bicycles.</li><li>• Supervision fee waiver.</li><li>• Assist with payment for ID/Birth Certificate</li></ul>
<p><b>Level II (smaller positive behaviors, but more frequent dosage):</b></p> <ul style="list-style-type: none"><li>• Hygiene/presentation.</li><li>• Timeliness/on time for reporting.</li><li>• Demonstration of positive attitude.</li><li>• Assisting peers.</li><li>• Specific # of 'made' appointments in a row</li><li>• Bringing proof back of applying to places in person (ie. Business cards, applications)</li><li>• Completing resume</li><li>• Learning new computer skills.</li></ul>	<p><b>Incentive/Reward Options:</b></p> <ul style="list-style-type: none"><li>• Verbal praise/affirmation.</li><li>• Written praise/affirmation.</li><li>• Social/peer praise.</li><li>• Token/tangible items (fishbowl #2).</li><li>• Specific report to PO w/ client present.</li><li>• Donated clothing.</li><li>• Clothing voucher.</li><li>• Partial supervision fee waiver.</li></ul>

**Response to Offender Violation Guidelines**

<p><b>Level I (more serious violations):</b></p> <ul style="list-style-type: none"><li>• Discontinues all reporting.</li><li>• Misses multiple reporting days.</li><li>• Overall lack of program participation.</li></ul>	<p><b>Intervention Options:</b></p> <ul style="list-style-type: none"><li>• Program termination.</li><li>• Staff with PO for action.</li><li>• Referral for WKCR/CSW (PO approval)</li><li>• Cognitive Behavioral Intervention (Carey Guide, pros/cons worksheet, decision making link).</li><li>• Team meeting with PO and client.</li><li>• Increase reporting and accountability requirements.</li><li>• Essays</li></ul> <p><b>*Give Options</b></p>
<p><b>Level II (lesser violations):</b></p> <ul style="list-style-type: none"><li>• Tardiness.</li><li>• Hygiene/dress issues.</li><li>• Lack of participation in workshops and activities.</li></ul>	<p><b>Intervention Options:</b></p> <ul style="list-style-type: none"><li>• Verbal or written reprimand.</li><li>• Cognitive Behavioral Intervention (Carey Guide, pros/cons worksheet, decision making link).</li><li>• Increase reporting/accountability requirements.</li><li>• Essays</li></ul> <p><b>*Give Options</b></p>
